has been Diagnosed with Acute Lymphoblastic Leukemia (ALL-Blood CANCER) . He has been started on chemotherapy as per BFM Protocol. The treatment part consists of Initial intensive phase for 6 months followed by maintenance phase for 2 & ½ years. Currently child has completed with 2 Cycles of chemotherapy and due for 3 more cycles of chemotherapy. He is on regular follow up with Rainbow Hospital (Hyderabad) Now he is in very critical condition at hospital . The cost of the treatment in intensive phase for chemotherapy, Hospitalization, Investigations along with supportive care with IV Antibiotic, IV Anti Fungal and Nutritional support is around 3-4 Lakh. The cost of blood products required during entire treatment would be around Rs 1.5/2 Lakhs. Any Unexpected complication cost may go high.

The cost breakup for intensive phase is as follows, it includes hospitalization, chemodrugs, investigation & Procedures, Antibiotics, Blood Products Etc .

Our Son is in very critical condition he is now taking ongoing treatment at Rainbow hospital since past 6 months , Pavan's father, works as a Coconut seller at street side ( Hyderabad), he is a daily wage earner, hardly manages to make ends meet. He is the sole

breadwinner and we cannot afford the treatment of our child. Our son is fighting daily to live another day. I pray God none of the parents ever have the bad fortune to witness their own son suffering from such a big “DISEASE”.

Family is completely exhausted with financial constraints and Mr Satish Family come from economically very poor background (BPL) Their Annual Income is coming up to 30,000/ Hence unable to bear the complete treatment cost of 3-4 lakhs/- . Myself very much worried about my Son Critical Illness and want our child to recover soon. We require your prayer and generous support for our Daughter treatment and early recovery
